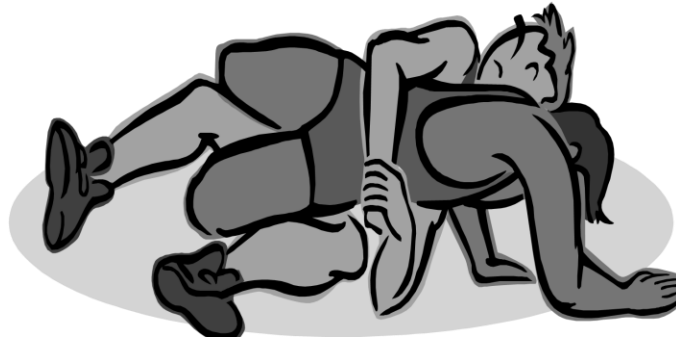

- Schools:** Aberdeen Central JV, Canton JV, Dell Rapids, Elk Point-Jefferson, Flandreau, Garretson, Lennox, Hamlin, Marion/Freeman, Miller/Highmore-Harrold, Parker, Sisseton, Tri-Valley, Winner
- Time:** First round at 10:00 AM. We will run the finals 30 minutes after the conclusion of the 5th/6th place matches.
- Weigh-Ins:** May be conducted at home as per SDHSAA regulations (at home, no earlier than 7:00AM; if departure is earlier than 7:00AM, weigh-ins can take place no earlier than one hour prior to departure).
- Skin Checks:** A certified trainer will be conducting skin checks starting at 8:45am. Teams will be directed to the elementary gym upon arrival. **All skin checks must be completed by 9:30am. All teams must have all participants together for their skin checks as we will complete them by team.**
- Entry Forms:** Please enter your official roster in the on-line tourney format. Information regarding **Track Wrestling Registration** will be sent in an upcoming email. Deadline for rosters is Thursday the 16th by noon. Please enter any unattached wrestlers as non-scoring entries. We will let you know by noon on Friday, January 15th if your non-scoring wrestlers will be included in the brackets. Deadline for entering head-to-head matches is Friday by noon.
- Seed Meeting:** We will not have a seed meeting. Preliminary seeds will be released on Friday, January 15th in the afternoon. If a coach wishes to challenge a seed, they must notify myself and Jay Swatek (Track Coordinator) by 7:00pm on Friday. The Event Coordinator will determine if the challenge will be upheld and final brackets published to coaches by 6:00pm on Friday. We will have a finalization meeting at the head table at 9:15am the day of the meet.
- Coaches Meeting:** There will not be a coaches meeting this year.
- Entry Fee:** **\$125.00 per team, payable to Tri-Valley High School**
- Awards:** **All awards will be read by the announcer. We will not have an official ceremony. Wall Charts, medals, and plaques will be sent home with coaches.**
- Admission:** All day pass – adults \$5.00 and students \$3.00
- Locker Rooms:** Assigned by the host school (a host will direct teams to locker rooms). We will have the MS Gym open for “team camps”. I’m requesting wrestlers keep their personal items in that gym to clear space for fans in the HS gym. We will be livestreaming the event in the MS Gym as well. Each team will have a designated area for their coolers, coats, gear, etc. Please help make sure this happens so as many fans can socially distance as possible. The bottom two rows of the HS gym bleachers will be reserved for athletes and coaches.
- Coolers:** No Coolers!
- Hospitality Room:** Will provide donuts/rolls & drink in the morning and a hot meal for personnel in the afternoon. We will not have a buffet style hospitality room open throughout the day.
- Trainers:** Orthopedic Institute Trainers will be available – Aaron Conklin
- Cheerleaders:** **Cheerleaders are not allowed to attend this event this year.**
- Spectators:** 2 vouchers per team personnel is allowed entrance to the event
